This request was made by Linda Heisterkamp and Ralph Heisterkamp Estates 607 S. West St Lake City, IA. The purpose of this Public Hearing is to inform area residents of the proposed action to vacate the street and transfer ownership to the Linda Heisterkamp and Ralph Heisterkamp Estates. A legal description of the property is as follows: The north portion of Isabella Street located between Outlot 3 and Outlot 4 of Carskaddon's Addition in the Southeast Quarter (SE ¼) of the Northwest Quarter (NW ¼) Section 18, Township 86, North, Range 33 West of the 5<sup>th</sup> P.M., Calhoun County, Iowa. The reason this vacating is being requested is because a portion of the garage on the adjoining property is located in the street.

# 5. Proposed Vacating and Conveyance of Isabella Street from S. West Street to the West of Parcel 863318180002

This request was made Andrew and Nicholle Winter 609 S. West Street Lake City, IA. The purpose of this Public Hearing is to inform area residents of the proposed action to vacate the street and transfer ownership to Andrew and Nicholle Winter. A legal description of the property is as follows: Isabella Street from S. West Street to the West of the Parcel 86331818002. The reason this vacating is being requested is because when the Winters purchased their home and property Isabella Street stopped in front of their barn and there was no additional rock. The Winters asked the City for approval if they could place rock from the "livestock" barn to their shed; it was approved. Over the last year the Winters have noticed "traffic" passing through Isabella Street down their shop drive. The Winters have contacted public works, who said there is no sewer/water running through Isabella Street. The Winters request Isabella Street to be vacated and ownership conveyed to them so they can be able to "label" it as a private drive for their shop.
