

Lake City Council Proceedings Monday, June 23, 2025

These minutes are as recorded by a City Council Member and are subject to Council approval at the next regular Council meeting.

The City Council of Lake City, Iowa met in special session at 5:00 pm with Mayor Schleisman presiding and the following members present: Bruns, Daniel, Gorden, Vogt and Wilson. Police Chief Gray and Officer Nachampassak were also in attendance. *Pledge of Allegiance* was recited.

Motion by Daniel, second by Gorden, to go into closed session under Code of Iowa Section 21.5 to evaluate the professional competency of an individual whose appointment, hiring performance or discharge is being considered, and when necessary to prevent needless and irreparable injury to that individual's reputation. Roll Call Vote: Ayes-Daniel, Gorden, Bruns, Wilson, Vogt. Nays-none. MC. Police Chief Gray provided his reason for seeking a closed session. Motion-Daniel, second-Wilson to accept Police Chief Gray's resignation effective July 4, 2025. Roll Call Vote: Ayes- Bruns, Daniel, Wilson, Vogt, Gorden. Nays-none. MC.

Council members Wilson and Gorden will serve on the hiring committee for officer interviews. Motion-Daniel, second-Wilson to direct Interim CA to post Police Chief position on City website, Facebook, city board and Iowa League of Cities. All Ayes. Nays-none. MC.

Council met with Calhoun County Sheriff Pat Riley to discuss cooperation from County Sheriff's office to help provide police protection and administrative services for Lake City. Estimated costs, coverage and terms were discussed. Officer Nachampassak schedule was also discussed. Motion-Vogt, second-Daniel to have Sheriff Riley draw up administrative services and protection coverage contract, have county and city attorney's review, and take to Board of Supervisors and City Council for approval at their next meetings.
