

## Lake City Council Proceedings July 7, 2025

These minutes are as recorded by the City Administrator/Clerk and are subject to Council approval at the next regular Council meeting.

The City Council of Lake City, Iowa met in regular session at 6:00 pm with Mayor Schleisman presiding and the following members present: Bruns, Daniel, Gorden, Vogt, Wilson. Also present were City Attorney Lauver, PW Director Zach Janssen, and CMB Manager Hannah Streeter. Pledge of Allegiance was recited.

**Consent Agenda:** Motion by Wilson to approve the consent agenda items consisting of the following items:

Citizens to Address the Council: Keith Lampe addressed the council with his hopes for the restoration of the bandstand on the downtown square. Dean Zenor has gotten the original blueprints to help with the restoration and Mr. Lampe is working on fund raising to cover the costs. There will be a fundraiser featuring a well-known band "Jazzed Up Big Band" performing a concert in the H.S. Auditorium on August 3, 2025. Tickets will be \$20, with proceeds going to the bandstand fundraising.

**Department Reports:** CMB Manager Streeter gave the council an update regarding the Community Building: the air conditioning has been fixed, and the football reunion went very well. Parks Board member Keith Lampe addressed the council regarding the complaints about mulberry trees growing at Goins Park, and he will be taking care of that. City Attorney Lauver advised council that she had met with Cody regarding zoning and will be making a few tweaks to our current property maintenance code.

Motion-Vogt, second Bruns to waive the 2<sup>nd</sup> reading and approve the 3<sup>rd</sup> and final reading of Ordinance #414 – An Ordinance Amending the Code of Ordinance by Vacating A Portion OF The Alley Located Between the South Half of Lot Four And The South Half of Lot One In Block 8, between North Center Street and North Illinois Street in Fulkerson's Addition to Lake City and Convey To The Adjacent Property Owner. Roll Call Vote: Ayes-Vogt, Daniel, Gorden, Wilson, Bruns. Nays-none. MC.

Discussion was held regarding the King Construction contract for the Well Project and Wilson motioned, Bruns seconded to approve Resolution 2025-23 – Approving Contract and Performance and/or Payment Bonds for the Well No. 6 and Well No. 7 Project.
